Dear Superintendent and Denali Borough School Board Members,

As a result of the School Board Meeting on Thursday, January 20th the below signees of this letter would like to formally serve you with notice that we intend to file a complaint against your surety indemnification bonds.

The Department of Education receives federal funding in compliance with the CDC guidelines. It is fully stated on their website. There is no codification of law with regards to any of these "guidelines".

Negligent infliction of emotional distress is considered property damage. Our children are our offspring and considered our property, we created them. This can be referenced under US Code 18 section 241 and 242. Conspiracy against rights and deprivation of rights.

The Superintendent is an advisory person to the School Board and at the close of the business before the vote on the continuation of the mask mandate, you personally pontificated unsubstantiated facts about Covid and offered no scientific or legal reason for continuation of this unconstitutional infringement of the children's personal rights.

This action is based upon the following failures of the School Board and the Superintendent for the school year 2021-2022:

1. Failure to head the Governor's no mask mandate for Alaska.
2. Failure to provide a safe environment for the children to learn in, masks have been proven to decrease brain function, inhibit in person learning, inhibit or further

harm children with learning disabilities, cause bacterial pneumonia, cause sinus infections, have a severe impact on tooth decay. These are all scientific facts.

3. Failure to follow the laws of this country and honor our constitution. A mandate or guidance from Non-elected, independent oversight body is NOT A LAW. Law comes from our legislative bodies not the FDA, CDC, or Dr. Fauci.
4. Failure to not uphold personal civil rights by denying our children the ability to be sovereign entities and breath free air.
5. Failure to uphold Federal HIPPA laws by initiating trace information about who is sick and where they got sick and who they may have infected.
6. Failure to uphold International Tribunal laws by violating the Nuremberg codes. There must be consent on the part of the INDIVIDUAL.

Based on the above 6 instances and the actions year to date of the School Board, we hereby formally request in writing that you cease and desist with all mask mandates within 3 days. Failure to heed this demand will lead to a legal complaint against the Superintendent and the School Board Members surety bonds for personal indemnification based on harm caused to the community as a whole and the children of Tri Valley School in particular.

The School Board and the Superintendent have not listened to the majority of their parents or students regarding this matter. This decision was forced by a small group of people threatening legal action against the school if their children contracted covid. We now have been backed into a corner by coercion and outright hijacking of our children's rights and we will stand for it no longer. You have no legal basis for what you are doing to our children. ALASKA HAS BEEN DECLARED A NO MASK MANDATE STATE. OSHA has dropped its requirements as well, the Supreme court has deemed all of this unconstitutional. The Nuremberg Trials were very specific....you cannot make us do something against our will when it comes to our bodies and our health.
